TITLE I SCHOOL PARENTAL INVOLVEMENT POLICY 2019-2020

- A. **Thomas G. Connors Elementary School**, as a recipient of Title I funds shall convene four (4) annual Title I parent meetings, at flexible times, where parents/guardians will be encouraged to attend. Each Hoboken district school shall develop its own written Parental Involvement Policy that shall describe specifically how it will use meetings for:
- Involving parents/guardians in the joint development of the school's written Parent Involvement Policy and in the planning, review, and improvement of programs addressing Title I, Part A requirements
 - Informing parents/guardians of their school's participation in Title I, Part A and to provide an overview of parental rights
 - Providing parents/guardians of participating children timely and specific information about the Title I, Part A programs to which their child has access
 - Informing parents/guardians of the school performance profiles required under 1116(a)(3), where the Hoboken schools must annually assess the progress of each participating school
 - Informing parents/guardians of their child's individual student assessment results, including an interpretation of such results
 - Providing parents/guardians information on curriculum, instruction, and assessment
 - Providing parents/guardians information on activities to support student learning
 - Providing parents/guardians information on how, when and where they will have reasonable access to staff on an ongoing basis
 - Providing parents/guardians information on how, when and where they will have opportunities to volunteer and participate in their child's classroom and to observe classroom activities.
- B. Each school shall jointly develop with parents/guardians a school-[home] compact that outlines how parents/guardians, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents/guardians will build and develop a partnership to help children achieve the State's high standards.

The School-[Home] Compact shall:

- Be distributed to the parents/guardians during the fall meeting
- Describe the school's responsibility to provide high-quality curriculum and instruction in a supportive and effective learning environment
- Describe ways in which parents/guardians will be responsible for supporting their children's learning.

ADOPTION

[The] District-Wide Parental Involvement Policy [including this School Level Parental Involvement Policy] has been developed jointly, and agreed on with parents of children participating in Title I, Part A programs. This Policy will be distributed to all parents of participating Title I, Part A children in an understandable and uniform format and, to the extent practicable, in a language the parents understand, at the beginning of each school year or when the child is determined eligible and begins participating in Title I, Part A programs.
